

Please support “Hokkaido Steiner Gakuen” through the ” Hometown tax donation program”

If you donate to the Hokkaido Steiner Gakuen Support Donation of Toyoura-cho's Hometown tax donation program, up to 60% of your donation will be donated to Hokkaido Steiner Gakuen and 30% will be contributed to the promotion of education, culture and sports in Toyoura-cho.

- * The Hometown tax donation program allows you to make a donation of 2,000 yen for the use of your choice in the area you wish to support.
- * There is a limit to the amount that can be deducted depending on your income when you donate through the Hometown tax donation program.
- * If you submit a Certificate of Receipt of Donation when filing your tax return, your donation will be deductible for tax purposes.

Eligible persons :

Non Toyoura-cho residents (those registered as residents outside of Toyoura-cho)

Token of appreciation

A letter of gratitude from the school

How to apply

● If you donate directly to Toyoura-cho :

60% of your donation will be subsidized by the school.
(30% will be contributed to the promotion of “education, culture and sports” in Toyoura-cho, and 10% will be used for expenses)

(1) Please fill out the “Toyoura-cho ” Hometown tax donation program” Application Form” .

- (2) After confirming the application form, our office will send you a payment form.
- (3) Please make payment at the post office using the attached payment form.
(The deadline for payment is by 12/31 (the date of the bank's receipt))
*It may take some time before or after the submission of the application form.
- (4) After confirming your payment, you will receive a “Certificate of Receipt of Donation” from Toyoura-cho.
This document is necessary when you file your tax return, so please keep it in a safe place.

● If you donate via “Furusato Choice” :

50% of your donation will be subsidized by the school.
(30% will be contributed to the promotion of education, culture and sports in Toyoura-cho, and 20% will be used for expenses)



you can only donate to Hokkaido Steiner Gakuen via Furusato Choice. Please note that donations cannot be made via other tax portal websites.

- ① Search for “Toyoura-cho, Hokkaido” and “Hokkaido Steiner School” on the Furusato Choice website.
- ② Select the menu corresponding to the amount you wish to donate and make your payment.
(Deadline for payment by the end of the year: Payment must be completed by 12/31)
* You can choose from a wide range of payment methods, including by payment via credit card, via carrier, at a convenience store, via bank transfer, via post office transfer, and others.
- ③ After confirming your payment, Toyoura-cho will send you a certificate of donation receipt.
This certificate is required for filing your tax return, so please keep it in a safe place.

● In both cases, you can use the One-Stop Special System.

Direct payment→Check the appropriate box on the application form,
Furusato Choice→Apply according to the instructions on the website.

Application deadline: January 10 of the year following the year of your donation
